

Job purpose

The Citizen Engagement Assistant at The Food Foundation will provide support for our citizen engagement work. They will work closely with the Citizen Engagement Manager, the Head of Development and Campaigns and the wider team to support our work with Young Food Ambassadors and Adult Food Ambassadors.

The Food Ambassador programme is a well-established volunteer programme, which aims to amplify the voices of people with lived or living experience of food insecurity in The Food Foundation's work. You will be a key member of the Citizen Engagement team and will be involved in supporting all aspects of our work, from administration, to events, to recruitment of new ambassadors.

- Are you people-centred, with experience of working with people from diverse backgrounds?
- Do you like a varied role, working across different teams both inside and outside of the organisation?
- Are you organised and have attention to detail?
- Are you flexible and able to work to tight deadlines?
- Are you a sensitive communicator who encourages inclusive practices?

Job purpose cont'd

This is an exciting and challenging role, providing support for our programme of work with citizens. We have been running a successful Food Ambassador programme for a number of years, supporting young people and adults who are experts by experience to campaign for changes to the food system to ensure everyone can access a healthy and sustainable diet. All of the ambassadors have experience of living on a low income.

The Food Ambassadors have met with Government Ministers, worked alongside top chefs and celebrities, been interviewed on the news, lobbied their MPs and spoken in meetings up and down the country. We are looking for a Citizen Engagement Assistant who can play a key role in our team. This is a varied job, and will need someone who can multi-task, can deal sensitively with people, and who is happy to get stuck in.

The Citizen Engagement Assistant will provide a mixture of administrative and project support for all our citizen engagement work, be responsible for nurturing and supporting the Food Ambassadors, and ensuring that the Food Foundation's evidence and recommendations for action are informed by their lived experience. This role will include the opportunity to lead on event logistics and smaller project management.

The postholder will be responsible for building the cohort of ambassadors, to ensure the programme is well representative of different communities from across the UK. They will manage the recruitment, screening and onboarding of new recruits. They will actively seek out ambassador opportunities and support Food Ambassadors to share their experience of the food system's impact and help ensure this is included in our communications, research, events and media.

With support from the Citizen Engagement Manager, the Citizen Engagement Assistant will prepare the Ambassadors for meetings with policymakers and the media, for panel discussions and talks, and will set up and support these opportunities.

The Citizen Engagement Assistant will also support with embedding the Food Ambassador Advisory Board (FAAB) at The Food Foundation. The FAAB has strategic oversight of The Food Foundation's direction and policies. The role holder will be responsible for setting up and facilitating FAAB meetings alongside the Citizen Engagement Manager.





Responsibilities

Main Responsibilities

- Act as the first point of contact for new enquiries about the Food Ambassador programme.
- Support the onboarding of new ambassadors, including outreach and recruitment.
- Liaise with and provide on-going and appropriate communication with existing ambassadors, including regular newsletters and monthly online catch-ups.
- Support with organising training and skills sessions for the ambassadors based on their skills / knowledge gaps or interests as food activists.
- Carry out administrative support for ambassador and other citizen engagement activities, including organising transport, overseeing payment of expenses, and ensuring all appropriate paperwork has been completed.
- Maintain a database of all our ambassadors and their activities. Work with manager to create end of year impact reports.
- Support at events and other activities such as media stunts, residentials, and meetings
- Assist the preparation and briefing of Food Ambassadors prior to events, meetings with
 officials or the media, including preparing briefing documents and presentations on our
 policy areas.
- Setting up and accompanying Food Ambassadors to meetings with officials, MPs, funders or the public, aiding communications and ensuring they are supported to share their experiences with confidence.
- Support the preparation of risk assessments and safeguarding, alongside the Citizen Engagement Manager and Head of Campaigns.
- Work with Food Foundation partners to include Food Ambassadors in new opportunities.
- Liaise with Ambassadors to prepare quotes, blogs and other material to feed into Food Foundation communications and reports.
- Support the Citizen Engagement Manager to update relevant policies in line with legal requirements e.g. Safeguarding.

This job description is intended as an outline indicator of general areas of activity only. The Food Foundation is a small charity and as such all staff are expected to vary their duties as necessary to meet the needs of the organisation.

Willingness to travel around the UK for events, meetings and recruitment of Food Ambassadors.

Willingness to work some evenings and weekends when necessary. (For example, we often do evening meetings with our Young Food Ambassadors as it has to be outside of school hours). Time will be given off in lieu.

Application process

Our recruitment process aims to see candidates at their best. That's why we set out the process from the beginning. The interviews will be held at the Brixton Office. We will aim to inform shortlisted candidate by 20th November and first round interviews will take place the week beginning 24th November.

The Food Foundation is committed to creating a diverse work environment, as we know a diverse workforce brings with it a diversity of ideas, thinking and different ways of working which enhance what we do. We recognise we have work to do to improve diversity and inclusion within our organisation. We welcome and encourage applicants from underrepresented backgrounds to apply.
